I, Piyush Prajapati, Practicing Company Secretary, have been appointed as Scrutinizer by the Board of Directors of Accuracy Shipping Limited on December 14, 2022 for conducting the Postal Ballot (e-voting process) through Link Intime India Private Limited (LIIPL) in a fair and transparent manner and ascertaining the results of e-voting carried out as per the provisions of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of Companies (Management and Administration) Rules, 2014 on the Resolutions contained in the Postal Ballot Notice dated December 14, 2022.

initiated in compliance with the MCA Circulars and in compliance with the requirements of the MCA Circulars, the hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope is not sent to the members for this Postal Ballot and the communication of assent / dissent of the members will only take place through the remote e-voting system.

Accordingly, the Company through its RTA has sent Postal Ballot Notice by email to all its shareholders as on dated December 16, 2022 (cut-off date) who have registered their email addresses with the Company or depository / depository participants and completed the process of sending Postal Ballot Notice through e-mail on December 16, 2022.

I hereby submit my report as under:

- The Company has availed the e-voting facility offered by Link Intime India Private Limited (LIIPL) for conducting remote e-voting by the Shareholders of the Company.
- 2) The e-voting period opened at 9:00 a.m. on Wednesday on December 21, 2022 and closed at 5:00 p.m. on Thursday on January 19, 2023.
- 3) The Members of the Company holding shares as on December 16, 2022 were entitled to vote on the resolution (Item no. 1) as set out in the Postal Ballot Notice dated December 14, 2022.
- 4) As stated in sub rule 3 of Rule 22 of the Companies (Management and Administration) Rules, 2014, an advertisement was published by the Company in 'Financial Express (All Edition)' in English Publication and 'Financial Express (Gujarat Edition)' in Gujarati Publication, on December 20, 2022 informing about the completion of electronic transmission of Postal Ballot Notice to the Members along with other related matters mentioned therein.
